- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

#### **Voting at the National Council meeting**

The Attendance ballot, if required, will occur at the meeting of the National Council 26/03/2025, the meeting will be held at the Hyatt Canberra, 120 Commonwealth Ave, Yarralumla ACT 2600.

#### **Absent Voting**

Any eligible member who is unable to attend the meeting shall, upon written application being made by him to the Returning Officer by 5:00pm (AEDT) on 25/03/2025.

The postal ballot, if required will open on 26/03/2025 and close at 10:00am Australian Eastern Daylight Time (AEDT) on 23/04/2025.
