A nomination form is available for electronic completion on the AEC Portal, www.aec.gov.au/ieb/. However, the nomination form must then be lodged in accordance with the Organisation's rules (see below).

A nominee for any office in a Zone shall be a financial member of the Association and allocated to that Zone as at the date of their nomination. Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 5:00pm Australian Eastern Standard Time (AEST) **on** 29/08/2024.

1. Emails to the AEC inbox that appear to be spam may be blocked. *It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.*

# Withdrawing Nominations

Nominations cannot be withdrawn after 5:00pm Australian Eastern Standard Time (AEST) on 05/09/2024. The withdrawal of such nomination shall be in writing, signed by the nominee and delivered to the Returning officer.

# **Voting Period**

The ballot, if required, will open on 26/09/2024 and close at 10:00am Australian Eastern Daylight Time (AEDT) on 31/10/2024. A postal vote packs will be mailed to eligible voters on 26/09/2024.
